ADDITIONAL INFORMATION FOR PARENTS/GUARDIANS

INSPECTORS HAVE PLAYED A CRITICAL ROLE IN THE SUCCESS OF THE ADOLESCENT TOBACCO USE PREVENTION ACT (ATUPA) PROGRAM. THE ATUPA PROGRAM HAS BEEN RUNNING SINCE 1997 AND, ANNUALLY, INSPECTORS CONDUCT OVER 20,000 INSPECTIONS OF LICENSED TOBACCO OUTLETS ACROSS NYS UNDER THE SUPERVISION OF PUBLIC HEALTH INSPECTORS.

COMPLIANCE CHECKS INVOLVE INSPECTORS BETWEEN 17 AND 20 ATTEMPTING TO PURCHASE TOBACCO PRODUCTS TO SEE WHETHER STORES ARE IN COMPLIANCE WITH STATE TOBACCO SALE REGULATIONS.

COMPLIANCE CHECKS ARE NOT PERFORMED AT LOCATIONS WHERE EITHER THE INSPECTOR IS KNOWN OR DOES NOT FEEL SECURE. TO REMAIN ANONYMOUS, INSPECTORS DO NOT PRESENT ID.

TRAVEL IS PROVIDED TO THE COMPLIANCE SITE BY THE PUBLIC HEALTH INSPECTOR.

INSPECTIONS OCCUR ANYWHERE WITHIN SARATOGA COUNTY.

SINCE IMPLEMENTING THE PROGRAM, COMPLIANCE HAS IMPROVED SO THAT NEARLY 95% OF RETAIL OUTLETS ARE IN COMPLIANCE (MEANING THEY WILL NOT SELL TO MINORS).
