Job Title:	REAL PROPERTY TAX RESEARCH TECHNICIAN

#### **Job Description**

This work involves the performance of a variety of clerical tasks in the control and maintenance of real property tax data. Although the duties are of a clerical nature, incumbents must be able to learn the terminology used in real property transactions and be able to read and understand technical documents such as tax maps. Work is performed under the direct supervision of a Tax Map Supervisor or other division supervisor in accordance with set procedures prescribed by the Saratoga County Real Property Tax Services Agency. Supervision is not a regular function of the position although some instructions may be given to lower-level clerical personnel. Performs related duties as required.

#### Minimum Qualifications (at least)

Graduation from high school or possession of a high school equivalency degree and two (2) years of full-time paid clerical experience involving the use of real property assessment or appraisal records

(Degree must have been awarded by a college or university by a regional, national, or specialized agency recognized as an accrediting agency by the US Department of Education/US Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. ### Typical Work Activities (\*Illustrative)

- Receives recorded documentation from County Clerk and sorts as to required action;
- Reviews deeds ensuring legal description, parcel and conveyance information are accurate are comparable to our tax map;
- Searches online records for documentation relating to real property and tax map revisions such as appropriations, leases, surveys and deed agreements;
- Assists general public with inquiries on assessment, tax map, parcel and auction related information;
- Assists surveyors/attorneys in process for filing of tax map documentation;
- Researches property records, tax maps, tax rolls and deeds for discrepancies and errors;

- Assists in tax foreclosure proceedings;
- May operate computing, copying, scanning, calculating and other office machines;
