### **Job Description**

Under general supervision, an incumbent in this position performs a variety of clerical assignments which involves typing on a personal computer to produce routine correspondence, records, reports, and/or other documents required. This level differs from typist in that the tasks performed are of a more difficult nature. General supervision is received from a higher-level clerical or administrative employee with some leeway allowed in the exercise of independent judgment in the application of established procedures and methods. Contact with the public may be required as part of job responsibilities. This position differs from the Senior Clerk in that typing skill is required and a routine requirement. Direction may be exercised over lower-level clerical staff. Performs related work as required.

#### Minimum Qualifications (at least)

- **A.** Possession of an Associate's Degree in Secretarial Science, Office Management, Business Administration, or related field and one (1) year of clerical experience which must have involved the routine use of standard office software such as, but not limited to Microsoft Suite: Word, Excel, Power Point and Access; **OR**
- **B.** Graduation from High School or possession of a high school equivalency diploma (GED) and three (3) years of clerical experience which must have involved the routine use of standard office software such as, but not limited to Microsoft Suite: Word, Excel, Power Point and Access.

(Degree must have been awarded by a college or university by a regional, national, or specialized agency recognized as an accrediting agency by the US Department of Education/US Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
