Job Title: HIGHWAY MAINTENANCE SUPERVISOR (PROMO)

Classification: Non-Competitive (No Exam Required)

Job Description: This is important supervisory work involving a high degree of responsibility for the efficient and economical use of workers, materials, and equipment in the maintenance and occasional construction activities in the County highway system. Work is carried out in accordance with established policy and procedures formulated by the Commissioner of Public Works, or other designated staff member, permitting considerable leeway in carrying out the detail of the work. The work is reviewed by inspections and through reports. Supervision is exercised over the activities of equipment and laborers by a continuing check of the work in progress. Does related work as required.

Minimum Qualifications (at least) Candidates must be currently employed with the Saratoga County Department of Public Works, in a permanent full-time status for at least ten (10) years.

SPECIAL REQUIREMENT(S):

Candidate must possess a valid NYS Driver's License appropriate for the "type" of vehicle to be operated, with the appropriate endorsements issued by the New York State Department of Motor vehicles at time, and for duration, of appointment.

NOTE: To meet current County wide and Departmental needs, those employees with experience in the operation of heavy equipment and with supervisory experience, will be given favorable consideration.

Typical Work Activities (*Illustrative)

- Coordinates and supervises the activities of county highway crews and the use of materials and equipment in the maintenance of county roads and bridges;
- Supervises snow removal and ice control activities on county roads;
- Coordinates the use and distribution of equipment between the various maintenance projects and in snow and ice control activities;
- Oversees and participates in new highway construction work;
- Assists in planning maintenance schedules and work loads;
- Reports to and confers with the County Highway Superintendent and his assistant regarding workers and equipment necessary for construction and maintenance projects;
