The Saratoga County Department of Health seeks an experienced candidate for a full-time Public Health Engineer I. The successful candidate should have good knowledge of the principles and practices of public health engineering and a strong background in environmental health activities.

Job Description

The work involves responsibility for the assisting in the planning, administration and performance of public health engineering duties concerned with the execution of one or more phases of environmental health programs. Work entails review and advising on problems requiring professional public health engineering expertise, assisting in the promotion of public health through application of environmental health practices, assisting in the enforcement of the provisions of local and State health matters, and investigations of related conditions and problems. Work is performed under general supervision of the Commissioner or other designated higher level engineering staff member, with some leeway allowed in carrying out details of the work. Supervision is not a requirement of this role. Does related work as required.

Minimum Qualifications (at least)

Possession of a Bachelor's Degree in Engineering or related field.

(Degree must have been awarded by a college or university by a regional, national, or specialized agency recognized as an accrediting agency by the US Department of Education/US Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. A list of acceptable companies who provide this service can be found on the internet at <http://www.cs.ny.gov/jobseeker/degrees.cfm>. You must pay the required evaluation fee.)

SPECIAL REQUIREMENT(S): Candidate must possess, and maintain, a clear and valid New York State Driver's License appropriate for the type of vehicle to be operated, in meeting the necessary transportation needs of the job.

The minimum qualifications for Public Health positions are mandated under New York State Health Code, Rules and Regulations (NYCRR) Title 10, Part 11. Participation in Public Health emergency preparedness drills and responses may be required. Select immunizations may be required at time of appointment or at any time throughout the course of employment according to New York State Department of Health or other oversight agency requirements.

Typical Work Activities (*Illustrative)

- Contributes to engineering, reviews of engineering or architectural plans, and specifications submitted to the Health Department for water and sewage systems, temporary residences, swimming and bathing facilities, realty subdivisions and all other related programs;
- Inspects, evaluates and reports on public and private water systems, sewage systems swimming and bathing places, water pollution, temporary residences, mobile home parks, and other public health regulated facilities and nuisances, suitability of soil for sewage treatment, and development proposals;
- Maintains relationships and cooperatives with State and Federal agencies of whose work and/or policies affect environmental health programs;
- Aids in developing public health engineering and environmental health policies and procedures;
- Collects environmental samples, prepares them for laboratory analysis and interprets laboratory results;
- Provides advice and assistance on public health engineering matters;
- Performs related duties as necessary.

**Typical Work Activities are intended only as illustrations of possible types of work that might be appropriately assigned to an incumbent of this title. Work activities that do not appear are not excluded as appropriate work assignments, as long as they can be reasonably understood to be within the logical limits of the job.*
