Job Title: SENIOR WASTEWATER TREATMENT PLANT OPERATOR (HELPs Program)

Job Description

This is supervisory and technical work involving responsibility during an assigned shift for the safe and efficient operation of a Type A Wastewater Treatment Plant with the facilities for the activated sludge process (including modifications). Supervision is received from operating personnel of higher rank with leeway permitted for carrying out details of the work. This position is distinguished from Wastewater Treatment Operator class by the supervisory nature of the duties and the greater responsibility involved. Supervision is exercised over subordinate Wastewater Treatment Operators and Trainees during the assigned shift. Does related work as required.

Minimum Qualifications (at least)

Satisfactory completion of an appropriate course of instruction approved by the Commission, Department of Environmental Conservation and possession of a Grade 3A License issued under the provisions of the New York State Sanitary Code. Possession of license at the time of application and for duration of appointment.

Typical Work Activities (*Illustrative)

- Supervises and participates in the operation of all equipment and processes relating to, treatment and disposal of wastewater in a safe, efficient and Economical manner;
- Monitors systems and equipment relating to the treatment of sewage and to the disposal of Sludge generated by the treatment process;
- Performs Lab work as required;
- Supervises total plant operation in absence of Chief Wastewater Treatment Plant Operator;
- Supervises bulk chemical unloading and transfer operations;
- Maintains all necessary records during shift;
- Makes inspection of all systems and machinery during assigned shift;
- May perform custodial duties in connection with upkeep of buildings and grounds;
- Assists in training programs for plant personnel.

Work activities that do not appear above are not excluded as appropriate work assignments, as long as they can be reasonably understood to be within the logical limits of the job.
