**Job Title:** AUTOMOTIVE REPAIRER(s) (Mechanic)

#### Job Description

This is skilled work involving responsibility for the overhaul, repair and maintenance of a wide variety of automotive and/or equipment including but not limited to engines, motors, motor-powered equipment, heavy construction, truck and automotive machinery. The work requires a thorough knowledge of the heavy truck/construction equipment repair trade or automotive repair trade. Ability to conduct NYS inspections of light and/or heavy fleet vehicles is a regular requirement of this position. Complete set of mechanics tools/storage will be necessary (partial stipend provided). General instructions are received from a higher-ranking Supervisor regarding tasks to be performed, with considerable leeway permitted in planning the details of each assignment. Supervision may be exercised over the work of other lower-level department technicians and/or operators; Does related work as required. (This is a 40 Hour, Mon-Fri vacancy with voluntary over-time opportunities available)

#### Minimum Qualifications (at least)

Graduation from High School or possession of an equivalency certificate (GED) and at least...  
Four (4) years of experience as an automotive or diesel mechanic which must have included diagnosis, repair and maintenance of automotive or diesel systems. (Preference may be given to candidates possessing experience with heavy equipment/diesel mechanics and that has possession of a NYS inspectors license.)

#### SPECIAL REQUIREMENT(S):

Candidate must possess a valid NYS Driver's License appropriate for the "type" of vehicle to be operated, with the appropriate endorsements issued by the New York State Department of Motor vehicles at time, and for duration, of appointment.

- Under supervision, overhauls, repairs and maintains, engines, motors, motor powered equipment used in automotive, construction and special purpose equipment, which may include combustion engines and equipment;
- Determines and troubleshoots mechanical and electrical defects in applicable equipment;
- Repairs and maintains brake systems, transmissions, ignition systems, rear ends, differential assemblies, fuel systems, hydraulic systems, electronic systems, and other related components and systems;
- Adjusts steering mechanisms and aligns wheels;
- Makes minor welding repairs to construction, truck and automotive equipment as necessary;
- Tunes engines;
- Tests motor/construction and related equipment in the performance of assigned repairs and duties;
- Attaches and removes snow plow blades and other auxiliary equipment;
