#### **Job Description**

Work involves responsibility for the safe, efficient operation and care of a variety of motor equipment used in road maintenance, construction projects and other public works activities, special projects and assigned tasks. An employee in this class performs manual tasks and recurring minor maintenance related to the operation of the equipment used; Employees also operate one or more types of automotive equipment as required for assignment; Work is usually performed under general supervision of a Heavy Equipment Operator or other higher level staff member, with some leeway allowed in the exercise of independent judgement in carrying out details of the work; May assist in leading and directing the work of assigned Laborer(s). Does related work as required.

#### **Minimum Qualifications (at least)**

Candidates must be currently employed in the Saratoga County Department of Public Works, serving continuously on a *permanent* full-time basis for at least **eight (8) weeks, as a Laborer**.

#### **SPECIAL REQUIREMENT FOR ACCEPTANCE OF APPLICATIONS**

Candidate must possess a CDL Class B with air brakes license, at a minimum, issued by the New York State Department of Motor vehicles at time, and for duration, of appointment.

(Degree must have been awarded by a college or university by a regional, national, or specialized agency recognized as an accrediting agency by the US Department of Education/US Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. #### **Typical Work Activities (\*Illustrative)**

- Operates a snowplow or related snow removal equipment;
- Performs minor mechanical repairs on automotive equipment;
- On assignment, operates bulldozer, grader, power shovel or other heavy automotive equipment;
